No. 358/2015.**—In exercise of the powers conferred by sub-sections (1) and (5) of section 6 of the Kerala Motor Transport Workers' Welfare Fund Act, 1985 (21 of 1985) read with paragraph 3 of the Kerala Motor Transport Workers' Welfare Fund Scheme, 1985, the Government of Kerala hereby appoint Shri K.
